What is Australia's position on Pre-Exposure Prophylaxis (PrEP)?

- PrEP is a treatment regime which involves an un-infected person taking antiretroviral drugs – such as Truvada - to reduce their risk of becoming infected with HIV.
- Studies are underway in Australia to look at the effective use of PrEP for our national context. Results of these studies may support a future application to the Therapeutic Goods Administration for Truvada use in PrEP.

- WHO global guidelines issued in 2014 recommend use of PrEP for people who are at high risk of HIV.

Here are a couple of brief dots:

PrEP

- Pre-Exposure Prophylaxis (PrEP) is a treatment regime which involves an un-infected person taking antiretroviral drugs – such as Truvada - to reduce their risk of becoming infected with HIV.
- Truvada is currently on the Australian Register of Therapeutic Goods (ARTG). To extend Truvada's indications for use in PrEP, the sponsor of Truvada, Gilead Sciences Pty, would be required to submit an application to the TGA, accompanied by scientific data to support the quality, safety and efficacy of the product for its intended use.
- Studies are currently being undertaken in Australia to look at the effective use of PrEP. The results of these studies may support a future application to the TGA for the use of Truvada in PrEP.
