## Applying for an Australia Awards Scholarship commencing in 2019

### Australia Awards Scholarships in Mongolia

Australia's international development assistance in Mongolia helps promote prosperity, reduce poverty, and enhance political stability.

Australia Awards Scholarships are prestigious international awards offered by the Australian Government to the next generation of global leaders for development. Through study and research, recipients develop the skills and knowledge to drive change and help build enduring people-to-people links with Australia.

Applicants are assessed on their professional and personal qualities, academic competence and, most importantly, their potential to impact on development challenges in Mongolia.

Applications are strongly encouraged from women, people with disability and other marginalised groups.

### Level of study

Australia Awards Scholarships provide citizens of Mongolia with the opportunity to obtain a qualification at an Australian tertiary institution.

Awards will be offered for commencement in 2019 within the following allocations:

**Category 1:** Employees in central and local governments; public universities, hospitals and schools and state-owned enterprises.

**Category 2:** Employees in the private sector, civil society and non-government organisations, private health and educational institutions and country-based offices of international organisations in the private sector.

Awards will be offered to study Masters by Coursework and Masters by Research.

### Australia Awards benefits

Australia Awards Scholarships are offered for the minimum period necessary for the individual to complete the academic program specified by the Australian education institution, including any preparatory training.

Scholarship recipients will receive the following:

- return air travel
- a one-off establishment allowance on arrival
- full tuition fees
- contribution to living expenses
- introductory academic program
- overseas student health cover for the duration of the scholarship
- supplementary academic support
- fieldwork allowance for research students and masters by coursework which has a compulsory fieldwork component.

### Eligibility criteria

### Country-specific conditions

In addition, candidates must also meet the following country-specific criteria:

- Applicants require a Bachelor's degree from a Mongolian university (with GPA no less than 3.0). Bachelor degrees from other countries must be recognised by Australian universities.
- Applicants working and living in Ulaanbaatar require an IELTS (Academic) overall score of at least 5.5 (or equivalent TOEFL) with no band score less than 5.0, valid at 1 January 2019.
- Applicants working and living in rural areas require an IELTS (Academic) overall score of at least 5.0 (or equivalent TOEFL) with at least Reading and Writing band scores no less than 5.0, valid at 1 January 2019.
- Applicants with identified and verified disabilities require an IELTS (Academic) overall score of at least 5.0 (or equivalent TOEFL) with Reading and Writing band scores no less than 5.0, valid at 1 January 2019.
- Applicants (apart from those with an identified and verified disability) must demonstrate at least two years' continuous employment, up to 1 February 2018 (maternity leave excepted). Category 1 applicants are required to have worked in the public sector for the two-years prior to 1 February 2018.
- Applicants with identified and verified disability do not need to demonstrate two years' continuous employment.

**Note:** IELTS and TOEFL certificates are valid for two years. Therefore, they must be dated no earlier than 1 January 2017.

**Note:** Only Academic IELTS scores are accepted for Australia Awards. General IELTS tests will not be accepted.

**Note:** Only paper-based and internet-based Official TOEFL tests are accepted for Australia Awards. Institutional TOEFL scores are not accepted.

**Note:** Applicants with a Master's qualification cannot apply for an Australia Award Scholarship in the same field.

### Special conditions

Applicants must provide all required information as requested in the application form. False information or not disclosing relevant information in the application could be considered fraud.

### Application dates

For study commencing in Australia in 2019

**Opening date:** 1 February 2018

**Closing date:** 30 April 2018

Applications and/or supporting documents received after the closing date will not be considered.

### The application process

#### Online applications

All applications must be lodged online through <https://oasis.dfat.gov.au/>

Applicants are required to apply online before the closing date. The on-line application facility (OASIS) experiences peak use in the days leading up to the closing date and applicants may experience delays.

#### Hardcopy applications

Applicants from rural or remote areas who do not have internet access must contact the Australia Awards Mongolia office on (11) 318852 as soon as possible to discuss options to lodge applications.

#### Supporting documents

Applicants must submit all of the relevant supporting documents listed in the *Australia Awards Scholarships Policy Handbook*.

Applicants must also provide the following documents to meet the specific requirements for Mongolia:

## The selection process

- Applications will be assessed and ranked after eligibility checking.
- Only top-ranked shortlisted candidates will be interviewed
- Interviewees will be assessed against the following criteria:
  - academic competence
  - potential outcome, specifically the contribution to development outcomes in Mongolia
  - professional and personal leadership attributes including relevant work experience.
- All applicants will receive feedback at the end of each selection stage
- Successful candidates will be notified no later than August 2018.

## Validation checks

Each application is checked against the eligibility criteria, to ensure all required documents are attached, notarised (as required) and valid and that selected courses are within approved fields of study and specialisations.

## Technical assessment

Eligible applications are independently assessed, ranked and returned to the Australia Awards—Mongolia office.

## Shortlisting

Shortlisting is managed by a panel of representatives from Australia and Mongolia. Successful candidates will demonstrate exceptional academic competence, leadership attributes and realistic development outcomes for Mongolia, meeting the Mongolian and Australian governments' priorities.

## Interview recommendation

All shortlisted applicants are interviewed. A selection panel recommends candidates who best meet the selection criteria and demonstrate realistic ideas to contribute to development in Mongolia.

The number of candidates recommended depends on the quality of candidates and the number of Australia Awards available in Mongolia. The Government of Australia approves candidates to be offered Australia Awards.

## Australia Awards offer

Before candidates are offered Australia Awards, they must have confirmed places at universities in Australia and meet all visa requirements (including health requirements).

## Preparatory training

Successful applicants will be required to attend:

- counselling on on-line application and course selection
- pre-departure briefing
- the university's Introductory Academic Program
- other required preparatory study on arrival in Australia.

Awardees must meet English language requirements for acceptance into courses in Australian universities. Awardees selected with an Academic IELTS score of less than 6.5 (or Official TOEFL equivalent) will complete an English language training program of up to 9 months in Mongolia. This program is compulsory and candidates must be released from work to attend.

Awardees with an Academic IELTS score of at least 6.5 (with no band score less than 6.0) will complete an Academic Preparation program in Mongolia before mobilisation.
