

Dear Directors,

To coincide with the changes to the Efic Act, the Minister has also issued Efic with a new Statement of Expectations. The main change to Efic's previous Statement of Expectations is that Efic is now permitted to support onshore resources projects and related infrastructure, where there is a demonstrated market gap in the availability of private sector finance. As you are aware, the changes to Efic's mandate are in response to an increasing number of resource projects in some market segments facing difficulties obtaining private market finance for otherwise viable projects.
