Dear Minister Tehan,

I have the honour to acknowledge receipt of your letter dated 16 December 2021, which reads as follows:

"In connection with the signing of the Free Trade Agreement between Australia and the United Kingdom of Great Britain and Northern Ireland ("the Agreement"), I have the honour to confirm the following mutual understanding reached between the Government of Australia ("Australia") and the Government of the United Kingdom of Great Britain and Northern Ireland ("the United Kingdom"):

- 1. Australia and the United Kingdom share an ambitious vision for trade in high quality food, drink and agricultural products between our two countries, building on positive arrangements already established under the Agreement on Trade in Wine Between the Government of Australia and the Government of the United Kingdom of Great Britain and Northern Ireland done at London on 18 January 2019.
- 2. The geographical indications listed in Annex A to this letter are protected in the United Kingdom, and the United Kingdom intends to seek protection for these geographical indications under the Agreement pursuant to paragraph (1) of Article 15.32 (System and Standard of Protection for Geographical Indications Intellectual Property). When protection is sought pursuant to that provision, the United Kingdom may amend its list of proposed geographical indications so that it reflects the geographical indications that are protected in the United Kingdom at that time. For clarity, should Article 15.33 (Protection of Geographical Indications Intellectual Property) of the Agreement apply, Australia will examine and publish for opposition under its

domestic requirements, the list of geographical indications notified to Australia by the United Kingdom, as soon as reasonably practicable following receipt of that list.

3. For the avoidance of doubt, this letter does not give rise to legally binding obligations.

I look forward to your letter in reply confirming that your Government shares this understanding."
