Company's general history

Established in 1991 and located in central Beijing (Chongwen district), China Rainbow International Investment Co., Ltd (China Rainbow) was formerly known as the China Hongqiao Travel Agency – the company originally was set up as a travel agency. China Rainbow is a direct subsidiary of the All-China Federation of Returned Overseas Chinese, a vice-state-level agency.

The All-China Federation of Returned Overseas Chinese was first set up in 1937 as the Returned Overseas Representative office in Yan'an for supporting the anti-Japanese war. After the PRC was founded, the organisation was restructured as an association representing returning overseas Chinese nationals in 1950. It is one of the member entities of the National Committee of the Chinese People's Political Consultative Conference.

Alongside, the Federation, Chairman Li Dacan is the ultimate beneficiary of Rainbow (we understand he owns about 25% of the company's shares). Mr Li is a member of the Shaanxi Political Consultative Conference.

Business operations in China (or abroad)

It currently <u>invests in 11 subsidiaries</u>, none of them are abroad. Austrade has no record of interaction with the company. We understand Chairman Li may have some investments in Australia (unconfirmed).

From Football Australia spokesperson

"Football Australia's interactions with the match promoter was focused on a friendly international match against FIFA World Cup Champions, Argentina. Prior to confirming our participation in this match, Football Australia engaged with the China Football Association, Beijing Football Association, and the Argentina Football Association.

The global nature of football ensures that Football Australia is regularly engaged with national teams from around the globe. Our focus is ensuring the development of football in Australia, and the securing of top-class opposition for our National Teams. Our decision to participate in the Beijing match was driven purely by football-related considerations. We also believe in the power of football to promote relations between nations, particularly at the people-to-people level.

In line with standard practice, Football Australia engaged with the Department of Foreign Affairs and Trade for logistical and other forms of support and continues to do so. This has also occurred with other national teams currently in Vietnam and in South Korea and occurs whenever our national teams travel abroad.

Football Australia sees the opportunity to play FIFA World Cup Champions, Argentina, in China as a unique sporting fixture which continues its strategy for our national teams to play against the world's best opposition."



Thanks for taking the time to meet yesterday. A few updates, and questions in red, we are hoping you can help with today:

1. TICKETS

If at all possible, we are hoping Football Australia can follow up with the promoter today (we have separately raised with the promoter's partner, Modun Group):

- 1. What platform will general tickets be sold on? Are foreign passport holders able to buy tickets on this platform? When will general tickets go on sale? Rumour here is that tickets will be released tomorrow, will sell out in minutes, AUD1,000+ general ticket prices.
- 2. Thank you for confirming 1,000 tickets will be set aside for Australian fans.
 - 1. Most importantly: how, where and when can Australians purchase these set aside tickets? How much are these tickets? Are they electronic or paper? If electronic, what is the platform?

- 2. How will they ensure those purchasing these tickets are Australian passport holders?
- 3. Are we able to set aside (if possible an additional) 100-200 tickets for the Embassy to purchase?

Please let us know if there are any difficulties with ticketing for Australian passport holders; we would be happy to discuss if we can might help.

I am advised that Rainbow will provide clarity on how the ticket operation will work later tonight. I will share information as I receive it. Great, look forward to hearing from you.

2. EMBASSY INVOLVEMENT

For your information only, the promoter's partner has asked for Embassy involvement – we are checking in on this now.

- 1. Request for Embassy to extend an invitation for an Australian Minister or State/Territory "dignitary" to attend
- 2. Argentine Ambassador, Mayor of Beijing and Ambassador as kick-off guests (presumably on the pitch just before kick-off, but we will try to confirm)
- 3. Australian Ambassador to China to record a 2-minute congratulatory VCR, which would be played on the big screen at the venue
- 4. Note the game will be filmed by CCTV 5
- 5. The promoter would like a confirmation letter from the Embassy regarding our involvement

Noted. They have also requested of me that I procure attendance by other senior state government officials (given federal parliament is sitting), and that I seek a video message of support from the PM for the Socceroos. We will let Canberra know.

3. EVENTS (PUBLIC DIPLOMACY)

We spoke to \$22(1)(a)(ii) last night, and will speak to the other States, Territories and Chambers today. We have a few questions, and the current plan around events is:

- 1. Post-Match High Level Networking Breakfast Reception: Ambassador Residence (TBC 16 June AM)
 - 1. would welcome your advice whether a player is able to attend this would help make the event successful. Will the coach also attend? We are happy to make this an early breakfast, so they can then fly out that afternoon. This is the best option for larger-scale event. All Australia-bound players will in Beijing until midday and could attend an event for, say, 30 minutes between 9-11am. I will also look into whether the CEO is able to attend. Unfortunately the Head Coach will have departed for Thailand by 9am. As it is not possible for myself and the CEO to arrive until at least 1pm on 15 June, the morning of 16 June would be the preferred window for a reception. We would appreciate the opportunity to feed into the invite list (by offering our sponsors with operations in Beijing to attend). Thanks, understood.
- 1. Approximately 100 people, Australian stakeholder groups, Platform to promote the FIFA Women's World Cup, Embassy hosted and funded.
- Children's Training Camp / Engagement Opportunity Prior to Networking Reception:
 Embassy Tennis/Basketball Court (TBC 14 June 1730-1815) This wont be possible on Match
 Day -1 as the team will be heading into their official pre-match training session. We are
 happy to do this whenever best suits the players. The Embassy is extremely close to the
 Intercontinental, and the timing of this event is flexible, but we are keen to proceed if at all
 possible.
- 3. **Training Session Attendance** Opportunity to attend Socceroos Training Session/s, various training grounds, TBC
 - 1. Welcome advice on training session times, venues and likely numbers of people who might attend so we can work out a plan. This could be accommodated on

Sunday 11 June. The training site is a Government Elite Sports Academy, so we need to ensure we can get access for Embassy etc especially if we are not opening it to general fans . If we were opening for fans Chinese or other groups (as Rainbow has requested) , we would need to be conscious of numbers, there is only a small seating area and we would have to use the running tracking as a fan marshaling area which is close to the pitch. Can be done just needs planning as the pitch is a bottle neck to bus access so if there was a big non-Aussie crowd would not be easy to get out. Our general understanding of academic facilities is access is foreigners needs to be planned well in advance; we recommend you raise this with the promoter now. Our preference would be for this to be an Australian contacts-only event, rather than a broad fan event, given the size of the venue.

- 4. **Communications** We will work with Tourism Australia in particular, FA and other partners, on this Happy to explore this how do you wish to proceed? We are really only thinking Australian Embassy Chinese social media. However we'd welcome any assets (photos, videos, etc) you can provide for use (only) on Chinese language social media. We'd also welcome advice if the team can bring merchandise; we are happy to pay for this, we are really keen to see our colours in the stands.
- 5. Screening of the game at the Embassy Bar + Support screening at an external venue (Embassy/community) What did you have in mind on this point? No further action for Football Australia. Embassy will support these for community members who can't attend the match.
- 6. Given the players arrive on 9/10 June (but noting executive do not arrive until 14 June), is there scope for an earlier event with players? At this stage it looks like this will be difficult particularly as some players will need additional training time after some time on holidays. If you have a specific concept in mind we would at least be prepared to consider. Not needed at this stage.

4. **CONSULAR BRIEFING AND MEDIA**

- 1. Our Canberra team is working with you on this, understand a tentative plan of 5 June.

 Awaiting details of this. I held a briefing with the CEO of our players association (PFA) this morning who advised they would be taking some advice from Amnesty International and Human Rights Watch to better educate themselves on current issues. I have set the expectation that Football Australia and PFA may need to reconnect on this particular issue. We will advise our team in Canberra, and thanks for letting us know.
- 2. Understand two media will be travelling. There are requests from a total of 5 Australian media to travel \$ 47F(1)

 Noted. We understand media need permission to film and potentially to import equipment. Football Australia may need to ask the promoter to arrange these permissions our experience is that it is important that these issues be raised this early with the promoter.

In relation to the first point, we received a media inquiry following Senate Estimates yesterday and have responded with the following:

From Football Australia spokesperson

"Football Australia's interactions with the match promoter was focused on a friendly international match against FIFA World Cup Champions, Argentina. Prior to confirming our participation in this match, Football Australia engaged with the China Football Association, Beijing Football Association, and the Argentina Football Association.

The global nature of football ensures that Football Australia is regularly engaged with national teams from around the globe. Our focus is ensuring the development of football in Australia, and the securing of top-class opposition for our National Teams. Our decision to participate in the Beijing match was driven purely by football-related considerations.

We also believe in the power of football to promote relations between nations, particularly at the people-to-people level.

In line with standard practice, Football Australia engaged with the Department of Foreign Affairs and Trade for logistical and other forms of support and continues to do so. This has also occurred with other national teams currently in Vietnam and in South Korea and occurs whenever our national teams travel abroad.

Football Australia sees the opportunity to play FIFA World Cup Champions, Argentina, in China as a unique sporting fixture which continues its strategy for our national teams to play against the world's best opposition."

We don't intend to make further comment. I will come back to you on the other matters asap. Thanks

Thanks for taking the time to meet yesterday. A few updates, and questions in red, we are hoping you can help with today:

1. TICKETS

If at all possible, we are hoping Football Australia can follow up with the promoter today (we have separately raised with the promoter's partner, Modun Group):

- 1. What platform will general tickets be sold on? Are foreign passport holders able to buy tickets on this platform? When will general tickets go on sale? Rumour here is that tickets will be released tomorrow, will sell out in minutes, AUD1,000+ general ticket prices.
- 2. Thank you for confirming 1,000 tickets will be set aside for Australian fans.
- 1. Most importantly: how, where and when can Australians purchase these set aside tickets? How much are these tickets? Are they electronic or paper? If electronic, what is the platform?
- 2. How will they ensure those purchasing these tickets are Australian passport holders?
- 3. Are we able to set aside (if possible an additional) 100-200 tickets for the Embassy to purchase? Please let us know if there are any difficulties with ticketing for Australian passport holders; we would be happy to discuss if we can might help.

I am advised that Rainbow will provide clarity on how the ticket operation will work later tonight. I will share information as I receive it. Great, look forward to hearing from you.

2. EMBASSY INVOLVEMENT

For your information only, the promoter's partner has asked for Embassy involvement – we are checking in on this now.

- 1. Request for Embassy to extend an invitation for an Australian Minister or State/Territory "dignitary" to attend
- 2. Argentine Ambassador, Mayor of Beijing and Ambassador as kick-off guests (presumably on the pitch just before kick-off, but we will try to confirm)
- 3. Australian Ambassador to China to record a 2-minute congratulatory VCR, which would be played on the big screen at the venue
- 4. Note the game will be filmed by CCTV 5
- 5. The promoter would like a confirmation letter from the Embassy regarding our involvement Noted. They have also requested of me that I procure attendance by other senior state government officials (given federal parliament is sitting), and that I seek a video message of support from the PM for the Socceroos. We will let Canberra know.

3. EVENTS (PUBLIC DIPLOMACY)

We spoke to s 22(1)(a)(ii) last night, and will speak to the other States, Territories and Chambers today. We have a few questions, and the current plan around events is:

- 1. Post-Match High Level Networking Breakfast Reception: Ambassador Residence (TBC 16 June AM)
- 1. would welcome your advice whether a player is able to attend this would help make the event successful. Will the coach also attend? We are happy to make this an early breakfast, so they can then fly out that afternoon. This is the best option for larger-scale event. All Australia-bound players will in Beijing until midday and

could attend an event for, say, 30 minutes between 9-11am. I will also look into whether the CEO is able to attend. Unfortunately the Head Coach will have departed for Thailand by 9am. As it is not possible for myself and the CEO to arrive until at least 1pm on 15 June, the morning of 16 June would be the preferred window for

a reception. We would appreciate the opportunity to feed into the invite list (by offering our sponsors with operations in Beijing to attend). Thanks, understood.

- 1. Approximately 100 people, Australian stakeholder groups, Platform to promote the FIFA Women's World Cup, Embassy hosted and funded.
- 2. **Children's Training Camp** / Engagement Opportunity Prior to Networking Reception: Embassy Tennis/Basketball Court (TBC 14 June 1730-1815) This wont be possible on Match Day -1 as the team will be heading into their official pre-match training session. We are happy to do this whenever best suits the players. The Embassy is extremely close to the Intercontinental, and the timing of this event is flexible, but we are keen to proceed if at all possible.
- 3. **Training Session Attendance** Opportunity to attend Socceroos Training Session/s, various training grounds, TBC
- 1. Welcome advice on training session times, venues and likely numbers of people who might attend so we can work out a plan. This could be accommodated on Sunday 11 June. The training site is a Government Elite Sports Academy, so we need to ensure we can get access for Embassy etc especially if we are not opening it to

general fans . If we were opening for fans Chinese or other groups (as Rainbow has requested) , we would need to be conscious of numbers, there is only a small seating area and we would have to use the running tracking as a fan marshaling area which is close to the pitch. Can be done just needs planning as the pitch is a

bottle neck to bus access so if there was a big non-Aussie crowd would not be easy to get out. Our general understanding of academic facilities is access is foreigners needs to be planned well in advance; we recommend you raise this with the promoter now. Our preference would be for this to be an Australian contacts-only

event, rather than a broad fan event, given the size of the venue.

- 4. **Communications** We will work with Tourism Australia in particular, FA and other partners, on this Happy to explore this how do you wish to proceed? We are really only thinking Australian Embassy Chinese social media. However we'd welcome any assets (photos, videos, etc) you can provide for use (only) on Chinese language social media. We'd also welcome advice if the team can bring merchandise; we are happy to pay for this, we are really keen to see our colours in the stands.
- 5. Screening of the game at the Embassy Bar + Support screening at an external venue (Embassy/community) What did you have in mind on this point? No further action for Football Australia. Embassy will support these for community members who can't attend the match.
- 6. Given the players arrive on 9/10 June (but noting executive do not arrive until 14 June), is there scope for an earlier event with players? At this stage it looks like this will be difficult particularly as some players will need additional training time after some time on holidays. If you have a specific concept in mind we would at least be prepared to consider. Not needed at this stage.

4. CONSULAR BRIEFING AND MEDIA

1. Our Canberra team is working with you on this, understand a tentative plan of 5 June. Awaiting details of this. I held a briefing with the CEO of our players association (PFA) this morning who advised they would be taking some advice from Amnesty International and Human Rights Watch to better educate themselves on current issues.

I have set the expectation that Football Australia and PFA may need to reconnect on this particular issue. We will advise our team in Canberra, and thanks for letting us know.

2. Understand two media will be travelling. There are requests from a total of 5 Australian media to travels 47F(1)

Noted. We understand media need permission

to film and potentially to import equipment. Football Australia may need to ask the promoter to arrange these permissions – our experience is that it is important that these issues be raised this early with the promoter.

- Australia will play Argentina on 15 June at the Worker's Stadium in Beijing.
 - o China Rainbow International is the Chinese promoter for the match.
 - The Football Australia delegation will comprise of players, officials and support staffs 47F(1)
- Football Australia (FA) sought clarity on visa processing for European-based players, especially where there is no Chinese Consulate nearby.
 - o They expect the visa process for Australian-based players should be more straightforward.
 - China Rainbow International (promoter) has worked with the Beijing Football Association to write to the Chinese Embassy in Canberra seeking their assistance with facilitation of visa on arrival for players and officials.
 - If visa on arrival is not possible, the Football Australia delegation will enter Hong Kong for pre-match training and visa processing, then spend 1-2 days in Beijing ahead of the match.
 - Football Australia's preference is for the players and officials to travel directly to Beijing, not via Hong Kong.
 - Football Australia has not had direct contact with the Chinese Embassy but has sought a meeting with the Embassy (possibly the Ambassador).
- We offered to raise with the Chinese Embassy a possible meeting with Football Australia. (And did so with Counsellor Political on the same day)
- We requested Football Australia share a list of their delegation to assist with visa processing by Chinese authorities including players, officials, and where they intend to lodge their visa application.
- We reiterated earlier Chinese Embassy advice that the Football Australia delegation should apply for 'M' class visas. We had advice that visa on arrival was not suitable for the activity. Football Australia would need to follow embassy advice.
 - s 47F(1) advised this was consistent with advice he had received from Chinese Embassies in Singapore and elsewhere in the region during his recent regional travel.
- We offered a consular pre-briefing for the Football Australia travelling delegation, for up to 1 hour virtually, and proposed Monday 5 June.
 - o The DFAT briefing would emphasise key information in our travel advice for China, similar to previous briefings for the team ahead of the 2022 World Cup in Qatar.
 - o Football Australia confirmed this timing should work for them. They may want to settle a time around their planning for the announcement of the squad.
 - We would follow up with specific timing in due course.

- We also offered a **separate media briefing for Channel 10** (1 journalist and 1 camera person)
 - We expected DFAT media colleagues would be in direct contact.
- We asked for any update regarding announcements related to the match
 - While Football Australia had originally planned a 27 May press conference, they were seeking an
 update from organisers whether this would take place or not.
 If so, it may include Australian and Argentinian representatives with the Chairman of China Rainbow
 International (promoter). We said Beijing Post would need to seek advice from Canberra when the
 request was made.
- We raised the **narrative on the bilateral relationship** in media reporting (22 May), and suggested the focus should be on Australia's elite sport, and this as a friendly match between quality sides. The match could show Australia positively, and link to the upcoming FIFA Women's World Cup. But Football Australia should avoid portraying this as a government-to-government initiative. Our role was limited to some practical assistance. The bilateral relationship was complex. Human rights in China could become a focal point, and we would like to avoid political overlay to a sporting fixture.
 - o Football Australia noted this and agreed to temper its narrative accordingly, and focus on sport rather than government/political angles.
- Football Australia said their organisation and players were **socially minded and socially aware** (made reference to Qatar world cup video). They understood media opportunities in China would be very tight.
 - Usually media cameras would cover the first 10 minutes of a training session, media may do one-on-one interviews/briefings with players.
 - o Football Australia would manage the risk if players were inclined to speak their mind, and would undertake messaging to players (with the Players' Association).
 - Football Australia noted that human rights concerns had been raised by \$ 47F(1) in recent comments.
 - We said this could be included in DFAT's pre-travel briefing to the delegation. There needed to be close discussion and a response plan.
- Football Australia will advise the **planned squad announcement date** some players may be approached by media (including re human rights) around that time.
- We said we were aware that Beijing Post would be liaising on important local issues: including tickets, public diplomacy activities; and social media.
- Separately, Football Australia said the **Young Matildas would undertake a 3 match tour of China** later in 2023, (partly funded by NFACR(?)) which would require further Football Australia contact and coordination with DFAT. Football Australia noted direct interest by China's Government in football, above other sports.

- We said we were aware that Beijing Post would be liaising on important local issues: including tickets, public diplomacy activities; and social media.
- Separately, Football Australia said the **Young Matildas would undertake a 3 match tour of China** later in 2023, (partly funded by NFACR(?)) which would require further Football Australia contact and coordination with DFAT. Football Australia noted direct interest by China's Government in football, above other sports.
