• Deeply concerned about the allegations of Hamas building infrastructure under UNRWA premises.

- UNRWA has advised that they systematically condemned any violations of the neutrality of UNRWA sites by armed actors, including the most recent allegations
  - UNRWA Commissioner General Philippe Lazzarini said on 11 February on X (formally Twitter) that "UNRWA did not know what is under its headquarters in Gaza. UNRWA staff left its headquarters in Gaza City on 12 October and we have not used that compound since we left it."
- Prior to 7 October, UNRWA undertook quarterly assessments by specially trained staff of all its facilities to review adherence to neutrality.
- The UN has announced an independent review of UNRWA's neutrality led by former French Foreign Minister Colonna
  - Australia looks forward to the outcomes of the review in due course.

# Announcement of an external review into UNRWA

- Welcome the announcement by UNRWA and the UN Secretary General of the independent review of mechanisms and procedures to ensure UNRWA's adherence to the humanitarian principle of neutrality.
- The review is being led by former French Foreign Minister Catherine Colonna and conducted by three Scandinavian institutions.
- It is premature to comment further on the review as its work is ongoing.

#### Establishment of an independent Review Group into UNRWA

On 6 February, the UN Secretary-General in consultation with UNRWA Commissioner-General Phillipe Lazzarini announced the appointment of an independent Review Group to assess whether UNRWA is doing everything within its power to ensure neutrality and to respond to allegations of serious breaches when they are made. It will also make recommendations on how to strengthen the mechanisms in place.

The Review Group is being led by former French Foreign Minister Catherine Colonna who is working with three Scandinavian development thinktanks: the Raoul Wallenberg Institute in Sweden, the Chr Michelsens Institute in Norway and the Danish Institute for Human Rights.

The Review Group began its work on 14 February 2024 and is expected to submit an interim report to the Secretary-General late March 2024, with a final report expected to be completed by late April 2024. The final report will be made public.

The review will be conducted in parallel with the investigation being undertaken by the UN Office of Internal Oversight Services (OIOS). The OIOS interim report was delivered to the UNSG on 28 February. s 33(a)(iii)

On 11 February, a joint IDF-ISA statement announced the discovery of "a significant underground Hamas intelligence asset and weapons" within UNRWA facilities. UNRWA said in a statement that reports of tunnels under its headquarters "merit an independent inquiry," and it "does not have the military and security expertise nor the capacity to undertake military inspections of what is or might be under its premises."

On 22 February 2024, UNRWA Commissioner General Lazzarini wrote to the President of the General Assembly in New York to express his profound regret that the Agency had reached breaking point. Lazzarini said that UNRWA's ability to fulfil the mandate given through General Assembly resolution 302 was now seriously threatened. Lazzarini said since the beginning of the conflict over 150 UNRWA premises have been hit by bombardment or shelling, killing over 390 people, and injuring over 1300

On 26 February 2024, Izzat Abdulhadi, Head of Palestinian Delegation to Australia, New Zealand the Pacific, published an op ed piece in The Guardian, calling on Australia to resume its funding of UNRWA.

On 11 March 2024, UNRWA Commissioner General Lazzarini wrote to Foreign Minister Wong to request a resumption of Australia's funding.

On 15 March 2024, Foreign Minister Wong announced that Australia would lift its temporary pause on funding for the United Nations Relief and Works Agency (UNRWA), following steps to strengthen the integrity of UNRWA operations.

If raised: Doesn't the OIOS outcome prove UNRWA staff are involved in terrorism?

- Important to note that the Colonna Review found UNRWA had robust principles and processes to safeguard neutrality
  - there was no systemic failure of neutrality
  - and no finding that UNRWA's operations had been systematically captured by Hamas or other terror organisations.

# If pressed: How do we know that UNRWA is not still employing terrorists?

- Welcome UNRWA's decision to dismiss all staff implicated in the OIOS report
  - have made clear to UNRWA that Australia has no tolerance for members of Hamas or any other terrorist group working for the organisation
  - we continue to expect UNRWA to take swift action to investigate any credible allegations.
- Note the independent Colonna Review made no finding that UNRWA's operations had been systematically captured by Hamas or other terror organisations.

# If raised: Why did Australia resume funding UNRWA before the OIOS investigation concluded?

- We resumed funding based on our assessment that strong steps had been taken to strengthen the integrity of UNRWA operations.
- Our funding arrangement with UNRWA includes stringent controls and safeguards that ensures compliance with Australian law.

#### Background

Australia has been a consistent and long-standing contributor to UNRWA, making a financial contribution every year since 1951.

On 27 January, the Foreign Minister announced Australia would temporarily pause disbursement of funding to UNRWA. The temporary pause affected \$6 million to UNRWA's Flash Appeal announced on 16 January. It did not affect Australia's core contribution to UNRWA for 2023-24 worth \$20.6 million, which was disbursed on 23 October 2023. At a 12 July pledging conference for UNRWA in New York, Australia committed to continuing our funding to UNRWA with a core contribution for 2024-25 worth \$20 million.

#### **Colonna Review**

On 6 February, the UN Secretary-General, in consultation with UNRWA Commissioner-General Lazzarini, announced the appointment of an independent Review Group to assess whether UNRWA is doing everything within its power to ensure neutrality and to respond to allegations of serious breaches when they are made. Catherine Colonna was appointed to lead the Review, working with three Scandinavian development thinktanks.

An interim report was submitted to the Secretary-General on 20 March (not public), and the final report on 22 April (public). The Colonna Review did not draw conclusions on the specific allegations made earlier this year; this was the role of the OIOS investigation.

#### <u>0105</u>

On 5 August, the UN Office of Internal Oversight Services (OIOS) announced it had completed its investigation into the alleged involvement of UNRWA staff members in the 7 October 2023 attacks. The UN Secretary-General had announced the OIOS investigation on 28 January 2024 following the initial allegations against UNRWA staff. OIOS has made findings in relation to each of the 19 UNRWA staff members alleged to have been involved in the attacks.

The report has not been made public. s 33(a)(iii)

According to public messaging from UNRWA on the release of the final OIOS report, in one case, no evidence was obtained by OIOS to support the allegations of the staff member's involvement, while in nine other cases, the evidence obtained by OIOS was insufficient to support the staff members' involvement.

do so. On 15 March 2024, the Foreign Minister announced Australia would lift the temporary pause on the funding following steps to strengthen the integrity of UNRWA operations.

Disbursement of Australia's payment to UNRWA was subject to the negotiation of a funding arrangement with appropriate control measures. The arrangement (signed 14 May) includes stringent clauses to ensure Australia's funding of \$6 million would be spent according to Australia's rigorous controls, sanctions and legal requirements. Funding was split into two tranches: s 33(a)(iii)

Australia continues to take its counterterrorism and sanctions obligations very seriously. All agreements to deliver humanitarian assistance have strict counterterrorism and sanctions requirements, which are closely monitored and applied. This is augmented by ongoing diligence and vigilance with our partners (like Canada and the EU), the UN and UNRWA.

#### Allegations of antisemitic curricula

The Colonna Review found "UNRWA has consistently worked on ensuring neutrality in its education" and "developed and implemented a range of frameworks, manuals, mechanisms and procedures to align all educational materials and methods with UN values, principles and guidelines." The Review recommended more work needed to be undertaken to replace problematic content.

#### US Lawsuit against UNRWA – 24 June

On 24 June, a group of more than 100 Israeli plaintiffs, comprised of victims of the 7 October Hamas terror attacks (and their families) filed a lawsuit against UNRWA in New York for \$1 billion in damages. An UNRWA spokesperson has said, "The United Nations, including UNRWA, enjoys immunity from legal process, as do United Nations officials, including those serving with UNRWA."

The allegations of the suit are reportedly based on UNRWA's practice of paying its 13,000 employees in Gaza in U.S. dollars, using cash transported to Gaza from the branch of the Arab Bank in the West Bank. Reports explain that UNRWA employees then convert their pay into shekels, utilizing Hamas money changers who took a percentage on transactions.

In addition, the lawsuit criticizes UNRWA for allowing the group inside its facilities. The lawsuit includes, "The resulting atrocities were foreseeable, and the defendants are liable for aiding and abetting Hamas' genocide, crimes against humanity, and torture."

#### Anti-UNRWA bills in the Knesset

On 23 July 2024, the Knesset passed the first reading of three anti-UNRWA bills that were endorsed by the Knesset Foreign Affairs and Defense Committee in May. The bills included a ban on UNRWA operating on Israeli territory [which under Israeli law includes East Jerusalem], stripping UNRWA personnel in Israel of legal immunities and privileges, and designating UNRWA as a 'terrorist organisation.' These bills would need to pass a second and third reading to become law. s 33(a)(iii)

Australia continues to take its counterterrorism and sanctions obligations very seriously. All agreements to deliver humanitarian assistance have strict counterterrorism and sanctions requirements which are closely monitored and applied. This is augmented by ongoing diligence and vigilance with our partners [like Canada and the EU], the UN and UNRWA.

### Colonna Review

The interim report of the independent Colonna Review was shared with donors on 22 March.

The final report [20 April] found UNRWA had robust principles and processes to safeguard neutrality, and had a more developed approach to neutrality than similar UN organisations. The report included recommendations to strengthen its neutrality policies and practices. It did not draw conclusions on the specific allegations made earlier this year that resulted in Australia pausing funding and UNRWA dismissing staff; the OIOS investigation is investigating these specific allegations.



Commencing on the 14 February 2024, the Review Group is expected to submit an interim report late March 2024, with a final public report expected late April 2024.
