There is one issue that your teams will need to look at in the coming days. It arises from a decision of the incoming Government to lift the minimum wage.

Minimum wage and superannuation guarantee rate increase

From 1 July 2022, the national minimum hourly wage for working in Australia will increase from \$20.33 to \$21.38 per hour. Missions should review Locally Engaged Staff and Private Domestic Worker renumeration and adjust them appropriately to reflect the new minimum wage. Further information is available from the Fair Work Ombudsman at www.fairwork.gov.au/newsroom/news/get-set-for-a-minimum-wage-increase. If you have any guestions, you should email myaccountservices@fwo.gov.au.

Also from 1 July 2022, the superannuation guarantee rate will increase from 10% to 10.5%. Further information regarding the superannuation guarantee is available from the ATO at www.ato.gov.au/Business/Business-bulletins-newsroom/Employer-information/Get-ready-for-super-changes-from-1-July/.
