
- We continue to press Israel to

    - allegations of torture and other forms of degrading treatment within the OHCHR report are shocking
  - urgently call upon Israel to ensure detainees are protected and perpetrators of violence held to account.

mistreatment of Palestinians in detention

On 31 July, UN OHCHR published a thematic report detailing allegations of torture and mistreatment, including sexual abuse, of Palestinian detainees in Israeli detention. The Israeli Military Advocate General's Office is also reportedly investigating 35 incidents in which Palestinian detainees have died in Israeli custody, although it is unclear where exactly those incidents occurred. Many of the allegations of abuse centre around the Sde Teiman detention facility, located in the Negev Desert, west of Beersheba.

The IDF's Military Advocate General announced on 27 May that it had opened investigations into allegations of criminal violations (including allegations of torture and abuse of detainees) during the course of the war.

## Allegations of torture against Palestinian detainees in Israeli detention

- Disturbed by report of the Office of the High Commissioner for Human Rights
  - allegations of torture and other forms degrading treatment are shocking
    - urgently call upon Israel to investigate all allegations, ensure detainees are protected and perpetrators of violence held to account.
- Israel must protect detainees in its custody from violence and ill-treatment.
- Australia continues to press Israel to grant access to detention facilities, including Sde Teiman [*Seh-Dee Tey-man*]
  - we are continuing to press Israel to work transparently with the International Committee of the Red Cross
    - it must be allowed to resume independent prison monitoring.
  - I (FM Wong) reiterated our support for ICRC's work directly to its Head of Office in Jerusalem in January this year.
- Australia has long voiced concerns to Israel on practices like administrative detention and detention of minors.
- All countries, including Israel, must respect international humanitarian law, including in relation to the treatment of detainees.

## Background

On 31 July, UN OHCHR published a thematic report detailing allegations of torture and mistreatment, including sexual abuse, of Palestinian detainees in Israeli detention. It noted claims there have been at least 53 deaths in custody. The Israeli Military Advocate General's Office (MAG) is reportedly investigating 35

Palestinian detainee deaths in custody. Many allegations centre on the Sde Teiman detention facility, a facility originally intended as a holding centre for terrorists after 7 October incursions. Due to overcrowding in prisons, terror suspects remain held at Sde Teiman for extended periods. Israel ended ICRC prison monitoring visits after 7 October, s 33(a)(iii) . Foreign Minister Wong met ICRC's Head of Delegation to Israel and the OPTs, Alessandra Megenon, in Jerusalem on 18 January 2024.

Following media reports in May (based on testimony of three Israeli whistleblowers who had been at Sde Teiman, as well as former prisoners) of widespread abuse of detainees, the IDF's MAG announced on 27 May that it had opened investigations into allegations of criminal violations during the course of the war. Following preliminary investigations, IDF Military Police officers arrived at Sde Teiman on 29 June to detain nine soldiers for alleged violent sexual abuse of a detainee in late May. The arrests prompted a riot in which dozens of right-wing and ultranationalist protesters broke into Sde Teiman and the Beit Lid military facility to halt legal proceedings against the arrested.
