# **KEY DEVELOPMENTS**

- Polls have closed in all states.
- Associated Press News (AP news) has declared the battleground state of North Carolina and Georgia for Donald Trump. This is good news for his achievable paths to victory
  - By winning North Carolina and Georgia, Trump could reach the 270 electoral vote threshold by carrying Pennsylvania or by carrying Michigan and Wisconsin. He also can win by carrying Wisconsin and Arizona, as well as other combinations involving Nevada
  - Trump is also slightly ahead in Pennsylvania with 84 per cent reporting. However, much of the uncounted vote is in deep blue Philadelphia and surrounding suburbs, meaning there is space for Harris to make up her current ~170,000 vote deficit in the state
  - He is also slightly ahead in Wisconsin (Trump 104,000 votes ahead, 81% counted) and Michigan (Trump 185,000 ahead, 53% counted)
- Harris' paths to victory have narrowed, making a win increasingly difficult particularly via holding the 'Blue Wall'
  - With Pennsylvania, commentators believe her best plausible path still lies with the Blue Wall combining Pennsylvania with Michigan and Wisconsin. She would also get over the line with Arizona in place of Wisconsin, or Arizona and Nevada combined in place of Michigan, but this is judged less plausible.
- As projected, AP news have declared Republicans have won the US Senate majority
  - Ohio flipping for Bernie Morena, giving the Republicans 50 seats
  - Nebraska retaining for Sen. Deb Fischer, giving the Republican at least a 51-seat majority.
- House race results are coming in, but still too early to call who will have majority.

## **Talking Points**

#### US election outcome

- The 2024 Presidential election is a matter for the people of the United States
  - we will not speculate about the outcome.
- There is strong longstanding bipartisan support for the Alliance in both Australia and the United States.
- We are committed to working with the US Government and Congress of the day in pursuing Australia's interests and strengthening the Alliance.
- The Alliance between Australia and the United States has never been more important given our challenging strategic environment
  - as the Prime Minister has said, Australia will continue to advocate for the United States to remain engaged in the world and our region, where it continues to play an indispensable role.

#### Australia-US relationship

- The United States is our vital ally and our closest global partner
  - we have strong cooperation across a broad range of areas including defence cooperation, foreign policy, development, climate, and trade and investment
  - the US is Australia's largest economic partner, with total two way goods and services trade between our countries valued at AUD\$98.7 billion and is our largest source of foreign investment
  - the Alliance, including through AUKUS, increases Australia's ability to protect itself and its interests by providing access to world-leading defence capability and technology, training and combined exercises
    - we exercise our own agency and make decisions in our own interests.
- The United States' security guarantee has been essential to the long period of stability and prosperity we've enjoyed in the Indo-Pacific
  - we share a vision for a peaceful, stable and prosperous region where sovereignty is respected.

- We are committed to deepening our cooperation, bilaterally and with regional partners and institutions, to support and deliver tangible benefits to the Indo-Pacific, including by promoting:
  - economic development, climate change cooperation, security, connectivity, good governance, disaster management, health, and resilience, consistent with regional and national priorities.

#### If raised: How will a [Harris/Trump] election victory impact the Alliance?

- Australia has an enduring commitment to our Alliance.
- We will continue to work with the US Government and Congress of the day in pursuing Australia's interests and strengthening the Alliance as we have always done.

## If raised: What does the election outcome mean for [X] policy?

- There is longstanding bipartisan support for the Alliance in both Australia and the United States.
  - *it is inappropriate to engage in speculation about policy measures the incoming US administration might adopt.*

#### If raised: How has the Government prepared for the US election outcome?

- It is usual practice ahead of significant international elections to *build relations with both sides and* ensure we understand the key issues and policies.
- As a matter of course, our embassy in Washington is engaging with US officials and Congressional representatives across the political spectrum.

#### If pressed: Is the Government 'rushing' to build relationships with Republicans?

- No as the Prime Minister said [4 November], the Government engages with people across the US political spectrum.
- This is usual practice ahead of significant international elections.
- As a matter of course, Ambassador Rudd and the Embassy in Washington engage with US officials and Congressional representatives.

# If raised: Are you concerned by the state of US democracy and potential for unrest?

- political violence has no place in our democracies.
- As the Prime Minister said [14 July 2024], in Australia and the United States, the essence and purpose of our democracies is that we can express our views, debate our disagreements, and resolve our differences peacefully.

#### If pressed: Are you concerned about the electoral integrity of the US election?

- The US election process and system is a matter for the people of the United States, as Australia's election processes and system are a matter for Australia.
- The US is a robust democracy with a range of checks and balances, which will determine the outcome.

## If pressed: Are you concerned about a possible contested outcome?

- The 2024 Presidential election is a matter for the people of the United States
  - it is inappropriate to speculate about the outcome, or comment on US electoral processes.

#### If pressed: Is Australia's sovereignty at risk under a new administration?

- No our Alliance strengthens our sovereignty and our security.
- Australia's sovereignty is stronger when we work with others towards shared goals, in ways that respect each other's national interests.

# If raised: Are you concerned about the US being distracted from the Indo-Pacific region?

- Regardless of the outcome, Australia and the US are committed to working together to ensuring a peaceful, stable, and prosperous region
  - where the United States continues to play an indispensable role.

# If raised: Will Ambassador Rudd remain in the role if Trump is elected?

- Ambassador Rudd is a highly effective Ambassador to the United States
  - his skill and experience mean he will work closely with whomever the people of the United States elect as their President.

• As the Prime Minister said "Australia decides who our ambassador is, and Mr Rudd is doing a terrific job".

#### If raised: Attempted assassinations of former US President Trump [13 July and 15 September]

- The Australian Government condemns the attempted assassination of former US President, Donald Trump in the strongest terms
  - violence should never be part of political expression or protest. Political violence has no place in our democracies.

## If raised: Trump criminal cases

- These are matters for the US legal system; we will not run commentary.
- The 2024 Presidential election is a matter for the US people
  - $\circ$  we will not be drawn into hypothesising about the outcomes.

#### Background

The United States 2024 presidential election will occur on 5 November EDT.

The Republican Party formally nominated Trump as its presidential nominee (15-18 July), who announced Senator J.D. Vance as his Vice President nominee. The Democratic Party formally nominated Vice President Harris, who Harris announced Minnesota Governor Tim Walz as her Vice President nominee (19-22 August). President Biden remains in position until inauguration of the next President on 20 January.

#### Attempted assassinations of former US President Trump

On 15 September, the FBI reported an assassination attempt against Trump at a golf course in West Palm Beach, Florida. This followed a previous attempt on 13 July, when Trump was shot in the ear during an election campaign event in Pennsylvania.

#### **Trump's trials**

On 31 May AEST, a New York jury found Donald Trump guilty of 34 felonies for falsifying business records to cover up hush money paid to a porn star. Following the US Supreme Court ruling on presidential immunity, Trump's sentencing was postponed *until 26 November*.

On 15 July, the federal criminal case against Trump relating to the mishandling of classified documents from the White House was dismissed on procedural grounds related to the process of appointing Special Counsel Jack Smith. Special Counsel Jack Smith has appealed the dismissal.

Trump also faces a federal criminal indictment of four felony charges in the District of Columbia relating to alleged attempts to interfere with the outcome of the 2020 election. Following the US Supreme Court ruling, Special Council filed a motion (2 October) that argued Trump's conduct on and before January 6 was as a private citizen, rather than in his official capacity *as President*.

He also faces a state criminal indictment in Georgia relating to efforts to reverse the election outcome in Georgia in 2020.

In the United States, being a convicted felon does not render you ineligible to run for the presidency.

## Background

The United States 2024 presidential election occurred on 5 November EST. At 21:44 *6 November* AEDT, Associated Press News (AP News) declared Trump as winning the US presidency. Donald Trump declared victory earlier than the AP announcement, addressing supporters at a watch party in Florida. Vice President Harris called to congratulate President Trump on his election win at approximately 2pm 6 November (6am 7 November AEDT) and delivered her concession speech to supporters in Washington DC at 4pm EST (8am 7 November AEDT).

Prime Minister Albanese tweeted a congratulatory message to Donald Trump on 6 November AEDT and issued a media release. He held a call with the President on the morning of 7 November AEDT, where he congratulated President Trump on his election victory. They discussed the importance of the Alliance and the strength of the Australia-US relationship, particularly in relation to security, AUKUS, trade and investment.

Foreign Minister Wong also tweeted on 6 November AEDT. When addressing media, she congratulated President Trump, and reaffirmed the strength of the Alliance and that Australia was looking forward to working with him and his administration.

Ambassador Rudd also tweeted a congratulatory message.

AP News has confirmed that Republicans have won control of the Senate (52-44), with some seats still to be called). *The House is still in play for either party (205-190), with races still to be called.* 

President Biden will remain in position until President Trump is inaugurated on 20 January 2025.

# Background

**US** Elections

The United States 2024 presidential election will occur on 5 November EDT. The Republican Party formally nominated Trump as its presidential nominee (15-18 July), who announced Senator J.D. Vance as his Vice President nominee. The Democratic Party formally nominated Vice President Harris, who Harris announced Minnesota Governor Tim Walz as her Vice President nominee (19-22 August).

On 21 July EST, President Biden released a statement on X (Twitter) announcing he would withdraw from the 2024 Presidential race. President Biden will remain President until the inauguration of the next US President on 20 January 2025.

On 4 November, the Australian Financial Review reported Australian officials are 'rushing' to engage Republicans and Trump allies ahead of the US Election. Stating the Foreign Minister Wong and Deputy Prime Minister Marles met with former Secretary of State Mike Pompeo as part of an effort to cultivate relationships with Donald Trump's allies. It was also reported Minister Wong met with Kevin McCarthy, former Speaker of the House of Representative and potential frontrunner to become Chief of Staff to Donald Trump. Ambassador Rudd has met with 66 of 100 Senators and 102 of 435 House of Representatives members.

On 4 November, the PM said "We engage with people across the US political system...When I was in the United States, I met with Republicans, I met with the Democrats, I met with people in Congress, people in the Senate." The Prime Minister met with Republican Congresspeople during his October 2023 visit and hosted a bipartisan reception for the Australia America Leadership Dialogue delegation in August 2023.

#### Comments by former Deputy Ambassador on US election outcome

On 4 November, the AFR published an article citing views of former Deputy Ambassador to Washington on the outcome of the US election. The Former Deputy Ambassador was quoted as saying "The Trump campaign seems to have eschewed appealing to Nikki Haley voters, who are potentially a quarter of Republicans in key states, to focus on speaking to Joe Rogan's gamer-bro audience – disgruntled, non-college- educated young men, predominantly white but making inroads with young black and Latino men attracted to Trump's machismo...They might take a punt on Trump on their favourite betting market – but will these traditionally low-propensity voters turn out to vote? My bet is those gamer chairs are too comfortable on the day".

#### Assassination attempts of former president Donald Trump

On 15 September EST, the FBI reported an assassination attempt against former US president Donald Trump at a golf course in West Palm Beach, Florida. The gunman was identified as 58 year old Ryan Routh, who was charged with two gun-related crimes on 16 September EST.

## Background

US Elections

At 21:40 AEDT on 6 November, Associated Press News (AP News) declared Trump as winning the US presidency. Donald Trump declared victory earlier than the AP announcement, addressing supporters at a watch party in Florida. Vice President Harris called to congratulate President Trump on his election win at approximately 2pm on 6 November (6am 7 November AEDT) and has delivering her concession to supporters in Washington DC at 4pm EST (8am 7 November AEDT).

Prime Minister Albanese and Foreign Minister Wong tweeted a congratulatory message to Donald Trump early on 6 November AEDT. Ambassador Rudd then sent his own congratulatory message.

AP News has confirmed that Republicans have won control of the Senate (52-42, with some seats not yet confirmed). Key House races are yet to be announced.

President Biden will remain in position until President Trump is inaugurated on 20 January 2025.

#### 2017 comments by Prime Minister Albanese regarding Donald Trump

On 4 November, footage from 2017 resurfaced of then Transport Minister Anthony Albanese saying Donald Trump "scares the s\*\*t out of me" during an interview. Opposition home affairs spokesman James Paterson was quoted in The Australian as saying Prime Minister Albanese's comments were 'grossly irresponsible' on 5 November.

On 5 November, Deputy Prime Minister Marles was asked about the previous statement by Prime Minister Albanese. He noted Prime Minister Albanese would 'be working very closely with that person [Harris or Trump], and the Alliance will be in good shape.'

Deputy Prime Minister Marles was further asked what he 'thought' of Donald Trump. He was also asked if Kevin Rudd's position as Australia's Ambassador to the United States was tenable, what the impact on Australia's efforts to stabilise our relationship with China would be, and if he had received assurances that AUKUS would continue, in the event of a second Trump administration.

#### Trump Trade Policy

While in Shanghai on 4 November for China International Import Expo (CIIE), media asked Minister Farrell to assess the consequences for Australia should the US impose higher tariffs on Chinese goods following the US election. In response, Minister Farrell noted it was our, particularly his, job to discourage the imposition of additional trade barriers. He noted that free trade provided peace and prosperity in our region, and that his argument to any incoming American government administration would be that Australia supported the concept of free trade, and wanted to continue to work with countries to ensure that free trade principles continue to apply to world commerce.

On 7 November, Shadow Minister for Trade and Tourism Kevin Hogan published a media release calling for the Government to secure a tariff deal with the US. In posting this release on X, he wrote 'In 2018, the Coalition in Government successfully secured an exemption for Australia from tariffs the then #PresidentTrump introduced on imported metals, safeguarding Australian industries. It is incumbent on Prime Minister Albanese and Ambassador Kevin Rudd, along with the Australian Government officials, to act quickly and prioritise respectful and constructive dialogue with US counterparts to secure a tariff deal'.

Australian officials 'rushing' to engage Republicans and Trump allies

On 4 November, the Australian Financial Review reported Australian officials are 'rushing' to engage Republicans and Trump allies ahead of the US Election. Stating the Foreign Minister Wong and Deputy Prime Minister Marles met with former Secretary of State Mike Pompeo as part of an effort to cultivate relationships with Donald Trump's allies. It was also reported Minister Wong met with Kevin McCarthy, former Speaker of the House of Representative and potential frontrunner to become Chief of Staff to Donald Trump. Ambassador Rudd has met with 66 of 100 Senators and 102 of 435 House of Representatives members.

On 4 November, the PM said "We engage with people across the US political system...When I was in the United States, I met with Republicans, I met with the Democrats, I met with people in Congress, people in the Senate." The Prime Minister met with Republican Congresspeople during his October 2023 visit and hosted a bipartisan reception for the Australia America Leadership Dialogue delegation in August 2023.

#### Comments by former Deputy Ambassador on US election outcome

On 4 November, the AFR published an article citing views of former Deputy Ambassador to Washington on the outcome of the US election. The Former Deputy Ambassador was quoted as saying "The Trump campaign seems to have eschewed appealing to Nikki Haley voters, who are potentially a quarter of Republicans in key states, to focus on speaking to Joe Rogan's gamer-bro audience – disgruntled, non-college- educated young men, predominantly white but making inroads with young black and Latino men attracted to Trump's machismo...They might take a punt on Trump on their favourite betting market – but will these traditionally low-propensity voters turn out to vote? My bet is those gamer chairs are too comfortable on the day".

On 4 November he published on LinkedIn, noting "a lot of people have been asking me what my thoughts are on the US election". He said 'My gut tells me that we will either see Kamala Harris surprise on the upside, or we will see Donald Trump grind out a close victory in the electoral college; I don't see any reason to suggest that Donald Trump will surprise by breaking his ceiling significantly. If Kamala Harris surprises on the upside, the election will be resolved on the night (although expect lots of unsuccessful legal shenanigans from the Trump team); if she doesn't it will take some days before we know whether Trump has scraped across the electoral college line.' He also noted some counties to particularly watch on election night.

#### Trump's trials

On 31 May AEST, a New York jury found Donald Trump guilty of 34 felonies for falsifying business records to cover up hush money paid to a porn star. Following the US Supreme Court ruling on presidential immunity, Trump's sentencing was postponed until 26 November.

On 15 July, the federal criminal case against Trump relating to the mishandling of classified documents from the White House was dismissed on procedural grounds related to the process of appointing Special Counsel Jack Smith. Special Counsel Jack Smith has appealed the dismissal.

Trump faces two other prosecutions. A federal criminal indictment of four felony charges in the District of Columbia relating to Trump's alleged attempts to interfere with the outcome of the 2020 election. Following the US Supreme Court ruling on presidential immunity, Special Council has filed a motion (2 October) that argues Trump's conduct on and before January 6 was as a private citizen, rather than in his official capacity.
