Summary

The following outlines security advice from the Diplomatic Security Division (DSD) relating to recent and potential further COVID anti-lockdown, anti-vaccination protest activity and threats against Australian missions.

Anti-lockdown/anti-vax and right-wing groups have called for and held protests outside a number of Australian missions over recent weeks (thanks reftel). Threats have also been made against Australian missions and staff. While purportedly relating to current lockdowns in Australia, and perceived police brutality against protesters, many of these groups are pursuing their own national political agendas.

2. Calls have also been made for Australian missions to be targeted in wider protest activity. To date, these calls to action have not resulted in large scale protests being directed at Australian missions.

Security Advice

3. Posts are encouraged to liaise with local security services and law enforcement if they become aware of any planned protest activity. Posts are also encouraged to review their contingency plans relating to civil disorder. Specific guidance and measures to be considered if peaceful and lawful protest activity takes place:

2. Calls have also been made for Australian missions to be targeted in wider protest activity. To date, these calls to action have not resulted in large scale protests being directed at Australian missions.

Summary

A protest organised by Reconnect Australia and NYC Freedom Fighters attracted approximately 300–400 people outside the New York Consulate building at approximately 4.30pm local time on 4 October. The protest was against the vaccine mandate.

Reconnect Australia and NYC Freedom Fighters aligned a planned protest march against the vaccine mandate on Monday 4 October. The planned protest commenced at 12pm at the New York City Department of Education headquarters in Brooklyn where the group formed to march over the Brooklyn Bridge towards City Hall. Following a scheduled rally and press conference at City Hall the group marched north towards 150 East 42nd St, outside the Consulate building.

2. Approximately 300 to 400 people participated in the march which attracted media attention, including noting Australian participants who were also marching against vaccine mandates in Australia.
3. Disruption to major roads occurred during the march and a vaccine testing tent being overturned was reported, however the protest while vocal remained largely peaceful. Once outside the Consulate building, the protest lasted approximately 2 hours.
4. Post (s22(1)(a)(ii)) was in contact with NYPD prior to the protest and uniformed officers were nearby when the protest made its way to the Consulate. Building management was also notified and stationed additional guards at the building entrance. s47E(d)
5. Planned protests occur often within New York City, however this is the first in a while involving an Australian group that attracted attention outside the Consulate building.
