The First Meeting of States Parties (1MSP) to the Treaty on the Prohibition of Nuclear Weapons (TPNW) was held in Vienna on 21–23 June 2022. Australia attended as an observer, represented by a non-executive parliamentarian, the Federal Member for Macquarie, Ms Susan Templeman MP, and supported by Vienna post (\$\frac{\text{s22(1)(a)(ii)}}{2}\$ and \$\text{s22(1)(a)(ii)}\$). Phil Twyford, New Zealand Minister for Disarmament and Arms Control.

The Australian delegation attended side-events on: 'Addressing victim assistance, environmental remediation, and international cooperation in accordance with the TPNW Articles 6 and 7', sponsored by Kazakhstan and Kiribati; 'Disarmament verification in the TPNW', sponsored by New Zealand and UNIDIR; 'The Pacific Bure', sponsored by Kiribati and a range of NGOs; and 'Nuclear weapons ban monitor: tracking progress towards a world without nuclear weapons', sponsored by Norwegian People's Aid. At the invitation of ICAN, Ms Templeman participated virtually in a Red Cross-hosted meeting in Brisbane on 22 June.
