As discussed with Paul, s 47F(1) have organised a delegation of six Australian parliamentarians to visit Washington DC on 20-21 September to advocate for Julian Assange's release and return to Australia.

Please find attached biographies for the delegation. s 47F(1)

The delegation would like to meet with relevant officials from the s 33(a)(iii) to discuss Mr Assange. They provided me with the following message on topics they would like to discuss:

- *The unified mission of the delegation is to secure the freedom of Julian Assange.*
- *The delegations diverse make up reflects the deep feeling in the Australian electorate for Julian to be free. It is also powerful, in that, irrespective of a change of government, there is bipartisan support for Julian's freedom among the political class.*
- *In our discussions with the Administration, we would like to*
  - *understand the United States perspective and address any concerns or misconceptions that exists;*
  - *express Australian's concerns - the depth and breadth of sentiment within the Australian electorate about Julian's case on a human rights level and the perceived press freedom and international relations;*
  - *reinforce bi-lateral ties - make sure that Julian's issues do not inadvertently strain the close relationship and long running ties between the two countries.*

They have also requested a meeting with the Department of State.

For your clarity, this delegation has been organised by s 47F(1). While one member is a Government backbencher, the delegation is not representing and carries no mandate from the Australian Government or the Australian Parliament.

I would welcome your advice on the availability of relevant officials from **s 33(a)(iii)** to meet with the delegation in the afternoon of Wednesday 20 September and Paul or I would be happy to answer any additional questions you might have to assist in making a decision to meet.
