**Re: Peacebuilding Fund Letter of Agreement Addendum No 2**

I am pleased to be informed of Australia's decision to make an additional contribution of Australian dollars four million (AUD 4,000,000), in two installments, to the Peacebuilding Fund.

Enclosed, please find for your countersignature, in two copies, the Peacebuilding Fund Addendum No 2 to the Letter of Agreement (LOA) between Australia and the United Nations Development Programme. The Addendum provides all necessary information to deposit the contribution.

With this additional commitment, Australia's total commitment to the Peacebuilding Fund now amounts to Australian dollars seven million (AUD 7,000,000).

It is confirmed that the funds contributed to the Peacebuilding Fund will be used in accordance with UN Security Council Resolutions relating to terrorism, including UNSC Resolution 1373 (2001) and 1267 (1999) and related resolutions and in accordance with the Recipient UN Organizations' own policies in relation to anti-terrorism.

I also take this opportunity to express our appreciation to Australia for its continued support of the Peacebuilding Fund.

**Addendum No 2  
to the Letter of Agreement  
between  
Australia  
and  
the United Nations Development Programme  
regarding the contribution of Australia to the Peacebuilding Fund**

Australia (hereafter referred to as the Donor) and the United Nations Development Programme (UNDP) acting as Administrative Agent of the Peacebuilding Fund on behalf of itself and all the Participating UN Organizations, ("the Administrative Agent") have agreed as follows:

Whereas in Article I, paragraph 1 of the Letter of Agreement concluded between the Donor and the Administrative Agent (hereinafter referred to collectively as the "Parties") on 22 December 2006, the Donor committed itself to make a contribution of Australian dollars one million (AUD 1,000,000) "and such further amounts as it may decide". On 18 March 2008, the Donor concluded an Addendum to the LOA for an additional contribution of Australian dollars two million (AUD 2,000,000).

The Donor has now agreed to make a further contribution to the Peacebuilding Fund. The Letter of Agreement between the Parties is therefore modified as follows:

Article 1 paragraph 1: The Donor agrees to make an additional contribution of **Australian dollars four million (AUD 4,000,000)**. This additional contribution will be deposited in two instalments:

1. 30 April 2010 AUD 2,000,000
2. 31 August 2011 AUD 2,000,000

Article IX paragraph 1, 2: Any action required or permitted to be taken under this Letter of Arrangement may be taken on behalf of the Donor by Catherine Walker, or by his or her designated representative and on behalf of the Administrative Agent by the Executive Coordinator of the UNDP MDTF Office, or his or her designated representative.
