EXCHANGE OF LETTERS UNDER THE PARTNERSHIP FRAMEWORK 2009-2013 BETWEEN THE WORLD HEALTH ORGANIZATION (WHO), GENEVA AND THE COMMONWEALTH OF AUSTRALIA REPRESENTED BY THE AUSTRALIAN AGENCY FOR INTERNATIONAL DEVELOPMENT (AUSAID) ON ACTIVITIES IN SUPPORT OF PUBLIC HEALTH IN SOUTH-EAST ASIA AND THE WESTERN PACIFIC REGIONS

- This letter initiates Exchange of Letters Number 50078/60 between AusAID and the WHO Headquarters ("WHO HQ"), Geneva in accordance with clauses 14 and 20 of the above Partnership Framework. The Terms and Conditions contained in Attachment A of the Partnership Framework apply to this Exchange of Letters.
- In addition to the WHO Medium Term Strategic Plan (MTSP) 2008–2013 objectives defined as key areas of collaboration in Clause 4 of the Partnership Framework, created by this Exchange of Letters supports WHO's MTSP Strategic Objective 8, "To promote a healthier environment, intensify primary prevention and influence public policies in all sectors so as to address the root causes of environmental threats to health."
- The parties agree that the title of the Activity to be used in all documentation, correspondence and publicity is "Water Quality Partnership for Health Water Safety Plans: Phase 3".
- AusAID offers to provide WHO HQ with a contribution for the implementation of the Activity as described in the Proposal "Water Safety Plans as normal practice: policy and institutional strengthening for WSP mainstreaming Phase 3" of 1 June 2012 (attached) and any amendments agreed in writing by AusAID.

5 The contribution is A\$15 million in line with the below payment schedule:

1 August 2012	1 July 2013	1 July 2014
\$5 million	\$7 million	\$3 million

- 6. The provision of the contribution is subject to compliance by WHO HQ with all of the requirements set down within the Partnership Framework, the Terms and Conditions and this Exchange of Letters.
- WHO HQ will be responsible to AusAID for disbursement of the contribution in accordance with the budget contained in the Activity Proposal.
- 8. WHO HQ will report to AusAID in accordance with the reporting requirements in the Partnership Framework, the Terms and Conditions and, any additional reporting requirements specified in this Exchange of Letters, including: a) a requirement for summary reporting every six months in line with the Objectives and Monitoring Table annexed in the Proposal.
- 9. WHO HQ will cooperate with an independent technical evaluation of the quality and performance of the Activity in 2014 to be administered and funded by AusAID.
- 10. WHO HQ and AusAID will also work to facilitate improved communications between WHO country office representatives and AusAID country programs.
- 11. This Exchange of Letters will be deemed to commence on the date of receipt by AusAID of acceptance of this Exchange of Letters and will conclude on 30 June 2016.
- 12. Please indicate your acceptance of this Exchange of Letters by signing both original copies and returning one signed copy to AusAID.
